NOTICE OF 59TH ANNUAL GENERAL MEETING

NOTICE IS HEREBY GIVEN THAT the 59th Annual General Meeting ("59th AGM") of Heineken Malaysia Berhad ("the Company") will be held virtually through live streaming and online remote voting from the broadcast venue at Sungei Way Brewery, Lot 1135, Batu 9, Jalan Klang Lama, 46000 Petaling Jaya, Selangor, Malaysia ("Broadcast Venue") on Friday, 12 May 2023 at 9.30 a.m. for the following purposes:

- To receive the Audited Financial Statements for the financial year ended 31 December 2022 and the Reports of the Directors and Auditors thereon.

- To approve the payment of a single tier final dividend of 98 sen per stock unit in respect of the financial year ended 31 December 2022.

- To re-elect Dato' Sri Idris Jala who retires by rotation pursuant to Clause 84 of the Company's Constitution as Director of the Company.

"That, subject to the provisions of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad, approval be and is hereby given to the Company and/or its subsidiaries to enter into any of the recurrent transactions of a revenue or trading nature with the Heineken Group of Companies and persons connected with Heineken as set out in the Circular to Shareholders dated 13 April 2023, which are necessary for the day-to-day operations and/or in the ordinary course of business of the Company and its subsidiaries on terms not more favourable to the related parties than those generally available to the public and are not detrimental to the minority shareholders of the Company and that such approval shall continue to be in force until:

- the conclusion of the next Annual General Meeting of the Company at which time it will lapse, unless by a resolution passed at a general meeting, the authority conferred by this resolution is renewed; or
- the expiration of the period within which the next Annual General Meeting of the Company is required to be held pursuant to Section 340(2) of the Companies Act, 2016 ("the Act") (but shall not extend to such extensions as may be allowed pursuant to Section 340(4) of the Act); or
- revoked or varied by resolution passed by the shareholders at a general meeting,

whichever is earlier;

And that the Directors of the Company be and are hereby authorised to complete and do all such acts and things as they may consider expedient or necessary to give effect to the Proposed Shareholders' Mandate."

- To consider any other business of which due notice has been given in accordance with the Act and the Company's Constitution.

NOTICE OF DIVIDEND ENTITLEMENT AND PAYMENT

Subject to the approval of Stockholders, a single tier final dividend of 98 sen per stock unit in respect of the financial year ended 31 December 2022 will be paid on 20 July 2023 to Stockholders registered at the close of business on 21 June 2023.

A Depositor shall qualify for entitlement to the dividend only in respect of:

- shares deposited into the Depositor's securities account before 12.30 pm on 19 June 2023 in respect of shares which are exempted from mandatory deposit;
- shares transferred into the Depositor's securities account before 4.30 pm on 21 June 2023 in respect of ordinary transfers; and
- shares bought on a cum entitlement basis according to the Rules of Bursa Malaysia Securities Berhad.

NOTES

1. Participation at 59th AGM

1.1 The Broadcast Venue is strictly for the purpose of complying with Section 327(2) of the Act which requires the Chairperson of the meeting to be present at the main venue of the meeting. Members/proxies/corporate representatives **WILL NOT BE ALLOWED** to attend the 59th AGM in person at the Broadcast Venue on the day of the meeting. Members are to attend, speak (including posing questions to the Board via real time submission of typed texts) and vote (collectively, "participate") remotely at the 59th AGM via the Remote Participation and Voting ("RPV") facilities provided by Tricor Investor & Issuing House Services Sdn Bhd ("Tricor") through its **TIIH Online** website at <https://tiih.online>. Members are advised to follow the procedures provided in the Administrative Guide for the 59th AGM in order to participate remotely via RPV.

1.2 For the purpose of determining a member who shall be entitled to participate in the 59th AGM via RPV, the Company shall be requesting Bursa Malaysia Depository Sdn Bhd to issue a Record of Depositors as at **28 April 2023** in accordance with the Company's Constitution and Section 34 of the Securities Industry (Central Depositories) Act 1991. Only a depositor whose name appears on the Record of Depositors as at **28 April 2023** shall be entitled to participate in the said AGM or appoint proxies to participate on his/her behalf in the said AGM via RPV.

1.3 A member entitled to participate in the meeting may appoint more than one (1) proxy to participate in his/her stead. Where a member appoints more than one (1) proxy, the member shall specify the proportion of the member's shareholding to be represented by each proxy.

1.4 A member who has appointed a proxy or attorney or authorised representative to participate at this 59th AGM via RPV must request his/her proxy to register himself/herself for the RPV at **TIIH Online** website at <https://tiih.online>. Please follow the procedures for RPV in the Administrative Guide for the 59th AGM.

1.5 Where a member of the Company is an exempt authorised nominee as defined under the Securities Industry (Central Depository) Act 1991 which holds ordinary shares in the Company for multiple beneficial owners in one securities account ("Omnibus Account"), there is no limit to the number of proxies which the exempt authorised nominee may appoint in respect of each Omnibus Account it holds. Where an exempt authorised nominee appoints more than one (1) proxy, the proportion of shareholdings to be represented by each proxy must be specified in the Form of Proxy. An exempt authorised nominee with more than one (1) securities account must submit a separate Form of Proxy for each securities account.

1.6 The Form of Proxy can be submitted through either one of the following avenues no later than **Thursday, 11 May 2023 at 9.30 a.m.** or in the event of any adjournment, no later than 24 hours before the time appointed for the adjourned meeting:

(b) Electronic lodgement of Form of Proxy - The Form of Proxy can be lodged electronically via TIIH Online website at <https://tiih.online>. Kindly refer to the Administrative Guide for the 59th AGM on the procedures for electronic lodgement of Form of Proxy via TIIH Online website.

1.7 Please ensure ALL the particulars as required in the Form of Proxy are completed, signed and dated accordingly.

1.8 Any authority pursuant to which such an appointment is made by a power of attorney must be deposited at Tricor's Office at Unit 32-01, Level 32, Tower A, Vertical Business Suite, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur, Malaysia, or alternatively at Tricor's Customer Service Centre at Unit G-3, Ground Floor, Vertical Podium, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur, Malaysia no later than 24 hours before the time appointed for holding the 59th AGM or adjourned general meeting at which the person named in the appointment proposes to vote. A copy of the power of attorney may be accepted provided that it is certified notarially and/or in accordance with the applicable legal requirements in the relevant jurisdiction in which it is executed.

1.9 For a corporate member who has appointed a representative, please deposit the **ORIGINAL/DULY CERTIFIED** certificate of appointment at Tricor's Office at Unit 32-01, Level 32, Tower A, Vertical Business Suite, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur, Malaysia, or alternatively at Tricor's Customer Service Centre at Unit G-3, Ground Floor, Vertical Podium, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur, Malaysia no later than 24 hours before the time appointed for holding the 59th AGM or adjourned general meeting. The certificate of appointment should be executed in the following manner:

(a) If the corporate member has a common seal, the certificate of appointment should be executed under seal in accordance to the constitution of the corporate member.

(b) If the corporate member does not have a common seal, the certificate of appointment should be affixed with the rubber stamp of the corporate member (if any) and executed by:
(i) at least two (2) authorised officers, of whom one shall be a director; or

(ii) any director and/or authorised officers in accordance with the laws of the country under which the corporate member is incorporated.

1.10 Pursuant to the Main Market Listing Requirements ("MMLR") of Bursa Malaysia Securities Berhad, all the resolutions set out in this notice will be put to vote by way of poll.

2. Agenda 1 : Audited Financial Statements

The audited financial statements for the financial year ended 31 December 2022 are laid in accordance with Section 340(1) of the Act for discussion only. They do not require shareholders' approval and hence, will not be put forward for voting.

3. Ordinary Resolution 2 : Re-election of Retiring Director

Clause 84 of the Company's Constitution provides that one-third (1/3) of the Directors of the Company for the time being shall retire by rotation at each AGM of the Company and all Directors shall retire from office at least once every 3 years but shall be eligible for re-election. Pursuant to this, Dato' Sri Idris Jala and Datin Ngiam Pick Ngoh, Linda are due for retirement by rotation. Dato' Sri Idris Jala has offered himself for re-election at the 59th AGM.

Leveraging the annual Board and Directors Effectiveness Evaluation, the Nomination & Remuneration Committee ("NRC") had on 24 February 2023, reviewed the performance and contributions of Dato' Sri Idris Jala. Based on the evaluation, the Board agreed that he has discharged his duties and responsibilities effectively and had provided valuable contributions to the leadership of the Board; and accordingly recommended that Dato' Sri Idris Jala be re-elected at the 59th AGM of the Company. Dato' Sri Idris Jala has abstained from deliberations and decisions on his own eligibility to stand for re-election at the NRC and/or Board Meetings and he will continue to abstain from deliberations and decisions on his own eligibility to stand for re-election at the 59th AGM of the Company. The profile of Dato' Sri Idris Jala is set out in the Directors' Profile in the Annual Report 2022.

Datin Ngiam Pick Ngoh, Linda did not seek re-election, after having served on the Board of the Company for more than ten (10) years since her appointment as Director on 3 December 2012. Hence, she will retain office until the close of the 59th AGM, and retires in accordance with Clause 84 of the Company's Constitution.

4. Ordinary Resolution 3 : Payment of Directors' Fees and Benefits

At the 58th AGM of the Company held on 12 May 2022, shareholders approved the payment of Directors' fee and benefits up to an amount of RM700,000 to the Non-Executive Directors of the Company for the financial year ended 31 December 2022. Details of the payment of the Directors' fees and benefits for the said financial year are disclosed under the Corporate Governance Report for the financial year ended 31 December 2022 which is available on the Company's website <https://www.heinekenmalaysia.com/corporate-governance/>.

There is no proposed revision to the existing Directors' Remuneration Package which was approved by shareholders on 25 November 2015. The Directors' fees payable to the Non-Executive Directors for the financial year ending 31 December 2023 are calculated based on the current composition of the Board and the Board Committees and the number of meetings scheduled for the Board and Board Committees whilst the benefits are mainly the provision of car and petrol card for the use of the Independent Non-Executive Chairman.

The proposed motion, if passed, will facilitate the payment to Non-Executive Directors of the Company during the financial year. In the event the proposed amount is insufficient (due to enlarged Board size), approval will be sought at the next AGM for the shortfall. Non-Executive Directors who are shareholders of the Company shall abstain from voting on this motion at the 59th AGM.

5. Ordinary Resolution 4 : Re-appointment of Auditors

The Audit & Risk Management Committee ("ARMC") had on 24 February 2023 undertaken an annual evaluation of the effectiveness of the external audit process and the performance, suitability and independence of the external auditors, Deloitte PLT, based on the criteria set out in the Corporate Governance Overview Statement in the Annual Report 2022.

The ARMC was satisfied with the suitability of Deloitte PLT based on the quality of audit, performance, competency and sufficiency of resources the external audit team provided to the Company and its subsidiaries ("Group"). The ARMC was also satisfied in its review that the provision of non-audit services by Deloitte PLT to the Group for the financial year ended 31 December 2022 did not in any way impair their objectivity and independence as external auditors of the Company.

Based on the ARMC's recommendation, the Board approved the proposed re-appointment of Deloitte PLT as external auditors of the Company for the financial year ending 31 December 2023 and recommended the same for shareholders' approval. Deloitte PLT, the external auditors, have indicated their willingness to continue in office.

6. Ordinary Resolution 5 : Proposed Shareholders' Mandate for Recurrent Related Party Transactions of a Revenue or Trading Nature

Ordinary Resolution 5, if passed, will allow the Company and/or its subsidiaries to enter into the recurrent related party transactions in the ordinary course of business and the necessity to convene separate general meetings from time to time to seek shareholders' approval as and when such recurrent related party transactions occur, would be eliminated. This would reduce substantial administrative time, inconvenience and expenses associated with the convening of such meetings, without compromising the corporate objectives of the Group or adversely affecting the business opportunities available to the Group. The Shareholders' Mandate is subject to renewal on an annual basis.
